

What is Mobile Health (mHealth)?

- **Definition:** The use of mobile technology to deliver healthcare services.
- Key Components:
 - Telehealth for remote consultations
 - Mobile healthcare providers
 - Outside of schools, in many cases a van equipped with medical equipment

- On-Site Preventive Care
- Early Detection and Rapid Testing
- Reducing Barriers to Healthcare Access
- Telehealth and Remote Consultations



The Need for Mobile Health in Keeping Youth Healthy

- Barriers to healthcare access: rural communities, transportation issues.
- The role of **early intervention and prevention** in reducing illness and hospitalizations.
- Lack of availability for school-based health centers in some areas.

Key Collaborations

- Students & Patients Providing feedback & engagement in services.
- Healthcare Providers Doctors, nurses, clinic staff, and student learners integrating mobile health into patient care.
- **Technology** Companies creating telehealth platforms, electronic health records.
- Government / Public Health Agencies & Potential Funders Ensuring regulations, funding, and large-scale adoption.
- Schools & Community Organizations Expanding access to care.
- Insurance & Payers Supporting reimbursement models for mHealth services.








What Are Mobile Health Partnerships?

- Types of partnerships: schools, healthcare providers, public health agencies, nonprofits, and businesses.
 - What are some other general organizations to partner with?
 - Who are some unexpected partners?
- **Benefits:** Increased access, convenience, and targeted health interventions, an established relationship for when emergencies and disasters occur.









Overcoming Obstacles

- Funding & Resource
 Limitations: Securing grants and public-private investments.
- Parental Consent & Participation: Educating families on the benefits of mobile health.
- Regulatory & Privacy
 Concerns: Navigating HIPAA
 compliance and school policies.
- **Physical Mobile Health Challenges:** vehicle maintenance, staff recruitment and retainment.

Sustainability Strategies for Mobile Health

- **Long-term funding models** (public health funding, corporate sponsorships, grants).
- Integration with school health programs for seamless service delivery.
- **Data-driven reporting** to showcase impact and secure continued support.







Denver Health Mobile Health Centers

Denver Health Mobile Health Centers (MHCs) includes:

Four Vehicles

Cancer Screening
Primary Care Services
Medication assisted treatment (MAT) services

25 Staff Members

Medical Director and Advanced Practice Providers
Medical Assistants, Clerks, and Drivers
Care Navigator & other programmatic staff

Mission:

To serve Denver communities in locations where people live, work, play, and worship.





Mobile Health Center 3 – Care in DPS

Mobile Health Centers (MHCs) provide basic primary care

Who can be seen?

Any member of DPS community that can walk up four steep steps.
Any member of DPS community that is ages >2 y/o through adulthood.

Who can't be seen?

Any non-member of DPS communityAny patients with mobility issues (no wheelchair access on MHC3, yet)

Locations?:

•Serving 6 Denver Public School Hubs

•Any DPS school that is requesting services that do NOT have a school-based health center





PARTNERING WITH DPS COMMUNITY HUBS?

Supportive Family Services located at 6 DPS Locations (one in each region)

English classes levels 1-4
GED English tutoring preparation
GED Spanish tutoring preparation
Citizenship preparation
Computer/technology support
Spanish conversation class
Workforce development: job placement, resume building, etc.









WORKING TOGETHER **Mobile Health + DPS**

Services offered on mobile unit:

- Physicals/WCC
- Injury and illness care
- Chronic condition management
- Protective Health Measures
- Routine lab tests
- Confidential care
- Enrollment Services
- Wellness exams
- Cardiovascular disease treatment (high blood pressure, heart disease, etc.)
- And more!





ASK US HOW TO SCHEDULE

All Patient Scheduling is handled through the DPS Community Hub Locations

- Hub staff conduct outreach to patients who are non-compliant for vaccines
- Hub staff offer appointments to students and eligible family members
- Hub staff support mobile clinics with expansions to other schools
 - Green Valley Elementary, ECE sites, Ashley Elementary, etc.

For any current patients that need to be scheduled on the mobile unit for services, please direct them to their nearest Community Hub

COST OF SERVICES / INSURANCE REQUIREMENTS

Educating Students + Parents

Cost for DPS students + siblings:

- All services are offered at NO COST to DPS students + siblings
- This is the same practice as school-based clinics

Cost for DPS parents:

- If a patient is insured (Medicaid/ private insurance) or is using a discount program (CICP), they will be charged their traditional co-pay fee and their standard coverage for primary care services will apply
 - Please note that co-pays vary by insurance or for CICP depending upon a person's income. The copay range for primary care is \$0-\$40.
- If a patient is uninsured (meaning income is \$0), we will serve them and there will be no cost for services.
- We will NOT serve any adult who lives out of Denver County and is uninsured.





ENGAGEMENT EFFORTS

How to Request & Host a Mobile Health Clinic Event

- Fill out an interest form on DenverHealth.org/MHC
- Meet with an MHC Staff member virtually
- Conduct a site-visit with MHC staff at your location to
 - Identify parking
 - Discuss logistics
- Connect virtually 1 week prior to the event
- Host the clinic
- Debrief & ideate future opportunities to partner

ADDITIONAL EFFORTS

To Improve mHealth Access at Denver Health

- School-Based Virtual (Urgent) Care Program
 - Partner with 22 DPS Schools without SBHCs
 - Uses mHealth technologies to allow DPS Nurses to virtually connect to SBHCs
 - Expanded care to an additional 9,000 students
- Dental Sealant Program
 - Uses mobile dental equipment to offer free preventative dental sealant services to DPS students
 - This free service is provided at 70+ DPS site
 - Work collaboratively with school nurses to enroll children to participate
- Substance Use Navigator (SUN) Program
 - Deploys behavioral health specialists alongside Denver Police Department to effectively respond to calls for behavioral health needs.




